CIRCULAR NO. 05 Dated: 29.03.2019

Since a long back, it was a statutory obligation to obtain 'in principle clearance' of the C.E (Dist) for installation/ erection of 315 KVA DTR in the network, whenever it was observed essential for the system. Accordingly, after reviewing the necessity, the site offices used to send such proposal regularly, even now. As a result, a considerable time is lapsed unnecessarily due to movement of the proposal for obtaining the requisite 'in principle clearance'.

Considering the load growth pattern & socio-economic condition of the localities, appropriate planning for providing power supply to the urban or semi-urban areas towards meeting up the load demand, installation/ erection of 315 KVA DTR in the network is a very common issue now-a-days. Necessary arrangement for procurement of this item on regular basis has also been taken care of and ensured accordingly.

Reviewing the present scenario and in order to speedy disposal, present practice of installing 315 KVA DTR in the system by obtaining 'in principle clearance' of the C.E (Dist) is hereby revoked and this specific issue may be settled at Zonal level henceforth. This Order is issued with the approval of the competent authority and takes an immediate effect, superseding all previous Order / Circular/ Guideline in this regard.
