

In pursuance of the Notification No:- 328/PO/O/C-IV/1E-60/13(Pt-VA) Dt- 26.12.2018 and Memo No- 333-PO/O/C-IV/1E-60/13(Pt-VIII) Dt. 31.12.2018 of the Dept. of Power & NES, Govt. of West Bengal, and Ref. No- WBERC/A-6/14/3286 dt. 31.12.2018 of West Bengal Electricity Regulatory Commission the entire distribution business & activities, presently undertaken by DPL along with all associated assets & liabilities will be transferred to WSEDCL on & from 01.01.2019. Accordingly, WSEDCL will be responsible for all functions, contracts, rights, deeds, schemes, bonds, agreements and other instruments of whatever nature relating to the respective undertakings transferred to in to which DPL was a party, subsisting or having effect on the date of transfer, i.e., 01.01.2019 in the same manner as DPL was liable immediately before the date of transfer and the same shall be in force and effective against or in favour of WSEDCL and may be enforced effectively as if WSEDCL had been a party thereto instead of DPL. At the same time the entire geographical area & customers presently being served by DPL will come under the jurisdiction & command of WSEDCL.

Accordingly the Divisional Manager, Durgapur Division is hereby authorised to take over the charge of the entire distribution business & activities presently undertaken by DPL along with all associated assets & liabilities from the Managing Director, Durgapur Projects Limited on & from 01.01.2019.

The officials of DPL presently involved in the distribution activities and functions are hereby requested to report to the Divisional Manager, Durgapur Division for discharge of his official function for maintenance of distribution network, activities & functions on & from 01.01.2019.
